## **Essential Duties & Responsibilities**

The Senior Researcher - Legal will carry out focused research and share insights on the new and existing national legislation, international agreements and regulations around trade, technology, skilled people movement and services that that would be of interest to India and its trading partners.

The Fellow is expected to:

- 1. **Plan:** Study and design research projects on international law related to economy, trade, technology, people movement and services. This is with regard to multilateral, plurilateral, regional and bilateral agreements, and especially rules to be developed during India's G20 presidency year 2023 and international agreements India which may benefit India
- 2. **Early Research:** Identify emerging gaps and outdated provisions in the prevailing legislation and regulations and good practices internationally.
- 3. **Fund:** Initiate and manage funding proposals end-to-end.
- 4. **Write:** Long form papers, reports and shorter articles based on substantial primary research and field interviews. These can be published and discussed at seminars, conferences, round tables and other meetings internally or externally
- 5. **Disseminate:** Engage, network and nurture relationships to create awareness & build brand repute. Represent the institution at Scholarly meetings and at potential target audience gatherings especially during India's G20 presidency year 2023
- 6. Participate in institutional activities and help with annual conferences and develop relationships. Contribute to building network with other think tanks, Corporates and Government especially during India's G20 presidency year 2023



- 7. **Training & Mentorship:** Enhance learning and development of junior staff through ongoing training and coaching. Work across the institution on various engagements like executive or other education as per internal and external deliverables outlined.
- 8. **Teaching:** Opportunities for teaching modules at partner institutions
